With the passage of the Strengthening Agency Management and Oversight of Software Assets (SAMOSA) Act, a new era of Federal Software Asset Management (SAM) is underway. For the first time since 2016, SAMOSA mandates federal agencies to assess and reinvest in their SAM programs, marking a critical step in enhancing operational efficiency, compliance, and cost control.

SAMOSA is a clear directive from Congress to refocus attention and resources on Software Asset Management (SAM). This act serves as a reminder that SAM isn't a one-time task but an ongoing process that evolves as technology, licensing models, and regulations change.

SAMOSA follows in the footsteps of the Making Electronic Government Accountable by Yielding Tangible Efficiencies Act (MEGABYTE), a policy enacted during the Obama Administration. MEGABYTE was widely considered a [success](#), establishing clear SAM responsibilities and requiring agencies to build centralized software inventories and enforce licensing accountability.

However, as MEGABYTE aged, it eventually faded from the spotlight, and many agencies eventually lost funding and focus for their SAM efforts. SAMOSA brings SAM back into the forefront of congressional oversight, reinforcing the necessity of a robust SAM practice that continuously adapts to complex software licensing environments.
